1. Welcome to Process, Participants and Introductions

3. MDNR/MS4/Stakeholder/Watershed Updates

Lynne Hooper, Boone County Urban Hydrologist, provided a report on the Countywide Chemical Sampling Project. The County partnered with the MO Dept. of Agriculture and University of Missouri (MU). An interactive map is live on the County's website at <u>www.showmeboone.com/stormwater/mda-sampling.asp</u> showing all sampling sites across the County and associated results of the chemical analysis for those sites.

4. Science Team Updates

Dr. Argerich's Synoptic Sampling - Olivia Bongiovi, Dr. Argerich's grad student, gave a presentation on the collection and analysis of samples Dr. Argerich's lab collected over the last five years.

USGS Chemical Analysis – Lynne Hooper stated that she had spoken with Dave Alvarez, USGS, and they still didn't have the results yet, but anticipates they will be in soon.

5. Action Team Updates

Chloride Task Force – Michele Woolbright provided a final report presentation, sharing background on why the task force was formed, their findings, and recommendations.

Chloride Study – Nicki Rinehart stated the intergovernmental agreement between the City, County, and MU has been approved by their regulatory authorities. The County is working on finalizing the contract with Geosyntec so the project can start.

Website Redesign – Nicki Rinehart shared that the County's IT department has approved the workorder to start updating the Help the Hinkson website. She's hoping to be able to preview the website at the next Stakeholder meeting in December.

Logo Contest – Michele Woolbright mentioned we need to create a CAM logo and discussed the possibility of a logo contest. Leanne Tippett Mosby/Tim Rielly made a motion to approve the idea of a CAM logo contest. Motion approved.
