 - Pay for our own samples
 - Hire a full-time employee to look at the existing science and communicate with stakeholders. There was discussion on what it would take to hire an employee. It was suggested that the FTE could be hired through the MS4.
 - Schedule regular joint meetings with the Science team to discuss potential projects and studies prior to presenting to the Stakeholders.
