Stakeholder/Science Team Updates

- Stakeholder Committee Next Meeting March 27th

- Science Team Met March 5
 - Discussed new chloride study
 - Tim Rielly urged Science Team to support riparian restoration projects
- Riparian Subcommittee Met March 12
 - Spring Riparian Workshop target date: May 18th
 - US Fish & Wildlife to partner and provide trees to participants
 - Possible riparian restoration project areas
 - City Parks arborist identified several riparian areas in parks that need work
 - Start small, then move to more ambitious projects
 - Lindsey Smith, Volunteer Coordinator at the City is working with tree keepers on possible projects, need to be on public property
 - Multi-day events, remove invasives one day and then plan trees on a follow-up day

Chloride Sampling (and Specific Conductance)

- Science Team recommended chloride sampling to be used in conjunction with Specific Conductance Data Logger Deployment
- Grab samples will help validate a specific conductance model
- Geosyntec to do the sampling
- Geosyntec also working on specific conductance in conjunction with Dr. Zeiger of Lincoln U

- Geosyntec presented on some findings from the current specific conductance study
- DNR is interested in this study for investigating chlorides elsewhere
- Data will be copied to the Science Team
- Action Team agreed with the Science Team and voted to recommend the study to the Stakeholder Committee at their next meeting. The work will be added to the Specific Conductance Study as an amendment to that contract.
